This is a request under the Freedom of Information Act 5 U.S.C. § 552.

I request that a copy of the following documents [or documents containing the following information] be provided to me.

**Please provide me with a copy of the "Pre-Release Draft Environmental Assessment for Maintenance Dredging of Key West Channel and Truman Annex Harbor" (PRDEA) dated February 11, 2003.** This is the document that preceded the April, 2003 "Environmental Assessment for Fleet Support and Infrastructure Improvements - Naval Air Station Key West" (EA). The PRDEA was used by reporting Agencies and is referred to in several of their letters within "Letters Received from Agencies" in the Appendix of the EA.

In order to help to determine my status to assess fees, you should know I am an individual seeking information for personal use and not for commercial use.

I request a waiver of all fees for this request. Disclosure of the requested information to me is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of the government and is not primarily in my commercial interest.

If you deny any part of this request, please cite each specific reason that you think justifies your refusal to release the information and notify me of appeal procedures available to me under the law.
